


### POST WORKSHOP SURVEY RESULTS

#### (JANUARY – JUNE 2017)

WINS successfully conducted **5 workshops** between 01 January and 30 June 2017. Over **180 participants** representing a large range of nuclear security stakeholders such as nuclear operators, radioactive sources users, carriers, regulators, law enforcement agencies, education and training institutions or international organisations, attended these events. Based on the feedback collected at the end of each workshop, WINS is proud to report that **99%** of the participants expressed their satisfaction and **97%** indicated that they would recommend WINS events to others!

We are obviously very thrilled by these results, which are a clear appreciation of our efforts to provide you with interesting and interactive opportunities for sharing your experience and lessons learned. In addition, such results reinforce our commitment to contribute to the strengthening of nuclear security worldwide. However, we wanted to further assess the medium term impact of these events on the participants and on the implementation of nuclear security programmes. In order to do that, we developed a series of questions to assess a set of topics such as the innovative and interactive character of our workshops, the impact of the discussions on participants' approach to security, and the opportunities for networking. The results of those who expressed an opinion are presented below:

- "To improve interaction between the qualified and not qualified work force for homogeneous exchange of subject matter expertise."
- "We are updating procedures to be more explicit about expectations and duties."
- "I make use of the WINS publications when developing management strategies in how to promote security of radioactive sources."



- "We have looked at alternatives to assessing training needs and reviewed our need for some form of modelling and simulation tools to better understand our response capabilities."
- "Highlighting Threats and mitigations that we may not have considered."
- "I have introduced the nuclear security performance management tool, by doing more desktop and force on force exercises to enhanced performance."
- "Looking at the cross-cultural differences in psychological assessment tools such as the MMPI."
